As a large agricultural country with pest-stricken area of 4,670 billion m², China's insecticide market is believed to be attractive; its insecticide demand reached 145,000 tonnes in 2007, increasing by 2% year on year. Despite less pest occurrence of crops, coupled with global financial crisis, China's insecticide demand in 2009 was only down 8.3% over 2008, with the volume still up to 129,000 tonnes. The canceling of 5 highly toxic insecticides has left new market valuing over USD1.4 billion, for eco-friendly insecticides in China.

China's demand for insecticide kept increasing by CAGR of 1.2% from 2004 to 2007. In 2010, it is expected to be 129,500 tonnes, similar to that in 2009. China's insecticide demand is believed to witness uptrend in the future, driven by expanding pest-stricken area, pests' growing resistance against insecticide, and growers' willingness to spend more on insecticides with rising incomes,.

Overcapacity is becoming an increasingly challenging problem for China's insecticide industry to solve. Chinese output was as large as 797,000 tonnes in 2009. With government's increasing attention to environmental conservation, China now is starving and ready for investment, advanced technology, and high quality insecticides, which are weak points of Chinese insecticide industry.

- Over 95% of insecticides in China are generic products, usually with hundreds of companies producing the same insecticide.
 R&D capacity is weak and investment in R&D is insufficient.
- 90% of China's insecticide companies are

of small scale with lagged technology, many of which are quite likely to be eliminated from the market in the future, due to government's increasingly strict environmental protection policies and growing intense market competition.

 Chinese insecticide manufacturers are doing well producing technical with relatively low production cost, but are weak in producing advanced formulations. Most formulations produced in China are EC and WP at present.

Meanwhile, China's insecticide market is greatly influenced by governmental policies, international legislations, crops (including conventional crops and GM crops) planting situation, insect pests' stricken area, natural disasters, end-users' habit and preference in insecticides uses and Chinese insecticide companies' development strategy.

So knowing current market situation will facilitate you to search for commercial opportunities in China's huge market; closely follow-up of government policies, natural disasters and area dynamics will definitely help you make quicker and wiser decisions.
