1. Introduction

- Telephone interviews with domestic producers and service suppliers
- Third-party data providers
- Customs statistics
- Comments from industrial experts
- Professional databases
- Information from the Internet

The data has been combined and cross-checked to ensure that this report is as accurate and methodologically sound as possible. Throughout the process, a series of discussions were held within CCM to systematically analyze the data and draw appropriate conclusions.

3. Executive summary

In the past few years, China's pyridine industry developed fast. The output increased from xxxx tonnes in 2010 to about xxxx tonnes in 2015, with a CAGR of xx%. At the same time, the import volume decreased from xxxx tonnes in 2010 to only xxxx tonnes in 2015.

The supply of pyridine in China was tight before 2010 when the domestic pyridine supply was highly dependent on import. However, with the development of China's pyridine industry, the domestic capacity of pyridine has increased a lot in recent years, especially in 2011, when the total capacity reached around xxxx t/a, nearly twice of that in 2010.
