### 1. Introduction

This report is about the analysis of financial performance of Chinese listed pesticide enterprises in H1 2017. Since H2 2016, the recovery of international crude oil market has driven up the prices of related basic materials and intermediates. In addition, after two years of destocking, demand from overseas pesticide market began to warm up. Therefore, China's overall pesticide market thrived in H1 2017. As representatives of pesticide companies in China, domestic listed pesticide enterprises are supposed to be the guides for the development of the whole industry. In this issue, annual reports of 20 main domestic listed enterprises involved in pesticides and/or pesticide intermediates were summarised and analysed.



# 2. Approach for this report

The report is drafted by diverse methods as follows:

- Desk research

The sources of desk research are various, including published magazines, journals, government websites and statistics, industrial statistics, association seminars as well as information from the Internet. A lot of work has gone into the compilation and analysis of the obtained information.

- Internet

CCM visited government websites and contacted with players in the domestic agrochemical industry through B2B websites and software as well as obtained registration information on the internet.

- Data processing and presentation

The data collected and compiled are sourced from:

- CCM's database
- Published articles in periodicals, magazines, journals and third-party databases
- Statistics from governments and international institutes
- Telephone interviews with domestic producers, joint ventures, service suppliers and governments
- Third-party data providers
- Comments from industrial experts
- Professional databases from other sources
- Information from the internet

The data from various sources have been combined and cross-checked to make this report as precise and scientific as possible. Throughout the process, a series of internal discussions were held in order to analyse the data and draw the conclusions.

The USD/CNY exchange rate used in this report is USD1.00 = RMB6.5909 on 1 Sept., 2017, sourced from the People's Bank of China.

Among them, nine enterprises locate in Jiangsu Province, four in Zhejiang Province, two in Sichuan Province, one in Anhui Province, one in Hubei Province, one in Hunan Province, one in Guangdong Province and one in Chongqing City. The performance of the 20 listed pesticide enterprises can reflect the status of China's pesticide industry.

# 1.3 Ranking of 20 Chinese listed pesticide enterprises by net profit in H1 2017

In H1 2017, the total net profit of the 20 main listed pesticide enterprises in China reached XXX million, largely up by XXX year on year. Among them, four recorded year-on-year drops in their net profit and only one of the four enterprises suffered losses, namely Hefei Fengle Seed Co., Ltd. The top three enterprises by net profit were Huapont Life Sciences Co., Ltd., Nanjing Red Sun Co., Ltd. and Jiangsu Yangnong Chemical Co., Ltd.

## 2 Analysis of 20 Chinese listed pesticide enterprises

## 2.1 Nanjing Red Sun Co., Ltd.

In H1 2017, Nanjing Red Sun Co., Ltd. (Nanjing Red Sun, stock code: 000525) had a good performance. To be more specific, it gained a revenue of XXX million, increasing by XXX year on year. Thereinto, the revenue of its pesticide business in H1 2017 increased to XXX million, accounting for XXX of the total, up by XXX compared with that in H1 2016.

It is worth noting that Nanjing Red Sun suffered year-on-year decreases in net profit in both 2015 and 2016 because of not only the industry downturn but also the company's spinning off its fertilizer business. But it turned better in H1 2017. Nanjing Red Sun gained a net profit with XXX million, up by XXX year on year. It mainly because of the better-off pesticide market in China in H1 2017.

Nanjing Red Sun's main products include pyridine, VB3, imidacloprid, paraquat, glufosinate-ammonium and chlorpyrifos. The company has six main subsidiaries, including Anhui Costar Biochemical Co., Ltd., Nanjing Red Sun Biochemical Co., Ltd., Anhui Redpont Biotechnology Co., Ltd., Nanjing Red Sun International Trading Co., Ltd., Nanjing Red Sun Agricultural Materials Chain Group Co., Ltd. and Red Sun International Trading (Shanghai) Co., Ltd.

What's more, on 12 June, 2017, Nanjing Red Sun announced that the company vigorously promoted its new paraquat formulation—paraquat 20% GW to response the ban of paraquat AS. At present, the product has been pushed in the market fully and sells well. Notably, it is the only new paraquat formulation that got formally registered. This marks that paraquat can be used continuously in China.
