## II-4 Import and export analysis in 2005~1H 2007

As from CCM's investigation, there is no import of NBS and NCS from 2005 to 2007. And the export of NBS is much larger than that of NCS.

## II-4.1 Export analysis of NBS in 2005~2007

From 2005 to 2007, the export volume kept increasing, whereas with reducing growth rate year by year.

## By manufacturer

Of all the manufacturers, Tianjin Tiancheng and Jiangsu East are the main manufacturers exporting NBS. In 2005 and 2006, their export volume accounted for 57.7% and 87.1% of the total. In 2007, it dropped to 46.4%.

## By export price

The export price of NBS is relatively stable from 2005 to 2006. The export price of NBS in 2006 was USD8.74/kg, USD0.01/kg higher than that of 2005. In the first half of 2007, the price of NBS has risen up to USD9.13/kg. This phenomenon is caused by two reasons. One reason is that the NBS manufacturers have to increase the export price of NBS to cope with the RMB appreciation...
