1 Introduction

In recent years, establishing large business groups by mergers and acquisitions (M&As) to expand production scale of enterprises has been one main guideline of the Chinese government for the pesticide industry. M&As has also become one of the key words in Chinese pesticide industry. As the deadline of China's *13th* Five-year Plan period (2016–2020) is coming, it's likely that China will see more M&A activities.

M&A is companies' normal response when they suffered market depression. It is also a requirement of Chinese pesticide industry due to the industry's own structure. M&As have been a developing trend to eliminate inefficient capacities and to improve industry concentration with the adjustment of national macro policies. It is believed that more and more outmoded enterprises will be eliminated or be acquired by the superior ones, with strict government control, increasing entry thresholds and increased production concentration.

The year 2018 and 2019 is a period of drastic changes in the pesticide industry. International and domestic agrochemical enterprises' mergers and restructurings are becoming faster, thus forming a new industry giant pattern in which the resources and advantages are more concentrated and the strong will be stronger. A number of new pesticide policies and the environmental protection requirements have increased the environmental protection & safety pressure of pesticide production. A group of scattered, disorderly and small enterprises are eliminated. The survival of the fittest competition intensifies.

According to the sales situation of China's leading pesticide enterprises, market shares of the top 5 enterprises, top 20 enterprises and top 100 enterprises in 2017–2018 were all higher than the corresponding figures in 2010–2016.
