Non-steroidal anti-inflammatory drugs (NSAIDs), consists of a series of medicines with the curative effects such as defervesce, acesodyne, anti-inflammation, and anti-rheumatism.

China's NSAIDs industry has been booming these years, ranking No.1 in Asia and No.2 in the world in terms of output volume. In 2008, the total output is estimated at over 120,000t/a. Meanwhile, many new products and preparations have been developed.

65% of NSAIDs produced in China is exported, mainly to Southeast Asian countries, European Union and North America.

Despite dozens of NSAIDs used in China, nine of them are most frequently used, including paracetamol, caffeine, aspirin, analgin, ibuprofen, naproxen, dichlofenac, indomatecin and phenacetin. Paracetamol is the largest product, taking up around 65% of total NSAIDs output currently.

The flourishing NSAIDs production and export in China is primarily attributed to Chinese government's policy, which lists them as main products of OTC medicines. Furthermore, Chinese policy on improving the accessibility and medicare for rural population will generate huge market potential for NSAIDs.

Secondly, China's NSAIDs industry enjoys strong market competitiveness worldwide, thanks to mass production, variety diversity, mature technology and low labor cost.

Last but not the least, the technology of NSAIDs in China is being further improved. Research institutes and their products performance are even superior to imported ones. Besides, overseas companies intending to invest in China's NSAIDs enjoy preferential governmental policies. And the low cost of land and labor in China provides a favourable condition for mass production.

For foreign players, to invest in China's NSAIDs industry can gain substantial profit from the huge potential market, by taking advantages of points mentioned above.

However, despite flourishing production and export, problems do exist in China's NSAIDs industry, such as falling price, reliance on overseas market, low-value added product exported, and so on.
